

Form of Resolutions: **Every Resolution to be moved at a meeting shall be affirmative in form, and shall begin with the word "That"**


For Example: **Resolved that the University be requested to**

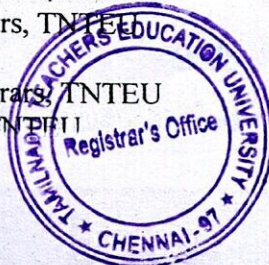
- Resolution(s) shall be clearly and precisely expressed and shall raise substantially one definite issue;
